- The Fire Prevention transition from El Dorado Hills Fire Department to Rescue Fire Protection District has been executed.
- Captain Warman has received forty-seven projects with ten plans have been finalized with roughly seven projected to be completed in the next two months.
- Rescue Fire Protection District has hired Fire Plan Review Inc and they have been diligent on finalizing plans.
- Three Fire Prevention assemblies with our local school districts teaching kids about fire safety.
- Captain Warman and Administrative Assistant Aja Mercado have been working together on a schedule and billing process for Prevention.

- Captain Warman was able to reach out and get reimbursement for uniforms and medical equipment through the ARPA Subrecipient Agreement (American Rescue Plan Act Funding) which is a Federal Grant.
- Being more proactive in social media. Appointed Captain Jones and Administrative Assistant Aja Mercado.
- Insurance through Atwood has gone up \$21,000. Pending to sign the agreement for a threeyear contract with Atwood.
- Bought out Administrative Assistant Aja Mercado from Blue Ribbon and on boarded Aja Mercado officially with Rescue Fire Protection District which saved the district \$3,200.
- Working on getting Fenix Access with the County.
- Captain Balak will be out at Sierra College on November 10, 2022, for recruiting.
- A contract has been signed with Hearts4heroes for the new stations Firehouse Dog.
